IMPORTANT NOTICE TO DEFENDANT

You have received a true copy of the offense(s) described in the complaint that will be filed in the Phoenix Municipal Court, unless another court is specified.

Please read and follow the instructions listed on the information envelope provided by the officer and visit the Phoenix Municipal Court's website at www.phoenix.gov/ticket to see if you are eligible to attend a defensive driving program, pay your fine by mail, or submit a written request for a trial or hearing. You must appear in court on the court date/time listed on your complaint if you have been charged with a criminal offense or your violation does not appear on the Fine/Sanction Schedule available at www.phoenix.gov/ticket.

Phoenix Municipal Court is open Monday through Friday (except legal holidays) 8:00 a.m. to 5:00 p.m. If you were cited into court on a weekend or a holiday, you must appear on the next court business day. You should bring your copy of the complaint with you.

If you require reasonable accommodations, pursuant to the Americans with Disabilities Act (ADA), or additional information, please contact the Court at 602-262-6421 or TTY: Use 7-1-1.

All motions, including motions to amend or dismiss, filed pursuant to Rule 16, Arizona Rules of Criminal Procedure, may be heard at the next scheduled court date. No court date continuances are granted by telephone.

You will need to come to Court prepared to pay any fine which might be imposed by the judge. Failure to appear or pay will result in additional monetary penalties, driver license suspension, and/or the issuance of a warrant for your arrest. In addition, the Court will notify the Department of Revenue to hold tax refunds; Motor Vehicle Department to hold vehicle registrations; and Collection Agencies to take action.

If you are required to pay fines, penalties, fees or other financial obligations as a result of this citation and you are unable to pay, bring this to the attention of court staff or the judge as payment over time or other alternatives may be available. Do not ignore the citation and the responsibility to pay as this may result in additional penalties and costs to you. Notice is hereby given that if you fail to appear in court as directed in this complaint, a warrant will be issued for your arrest (A.R.S. 13-3903(F)).

CRIMINAL TRAFFIC

Notice is hereby given that if you fail to appear as directed in this complaint on a criminal charge, a warrant will be issued for your arrest and your driver license will be suspended (A.R.S. 28-1557(B)(1)).

CIVIL NON-TRAFFIC

Notice is hereby given that if you fail to appear as directed in this complaint on a civil non-traffic charge, a default judgment will be entered against you and a civil sanction will be imposed (17C A.R.S. City Ct.Local Prac. and Proc.Rules, Phoenix, Rule 2.19).
