Statement of Probable Cause

ON FEBRUARY 15, 2020 AT APPROXIMATELY 1627 HOURS AP1 AARON D JACKSON COMMITTED TRESPASSING, RESISTING ARREST, AND FAILURE TO PROVIDE ID. AARON WAS OBSERVED ON THE SOUTH SIDE OF THE QUICK TRIP GAS STATION ATTEMPTING TO PAN HANDLE FROM TWO UNKNOWN FEMALES THAT HAD JUST EXITED THE QUICK TRIP AND WERE ATTEMPTING TO ENTER THEIR VEHICLE TO LEAVE THE PROPERTY WHEN THEY WERE CONTACTED BY AARON. OFFICER BAKER 10212 AND I OBSERVED AARON ON THE DRIVERS SIDE OF THE VEHICLE TALKING TO THE TWO FEMALES. THROUGH MY TRAINING AND EXPERIENCE AND PREVIOUS INCIDENTS WITH THE QUICK TRIP EMPLOYEES THEY HAVE HAD ON GOING ISSUES WITH SEVERAL TRESPASSERS AND PAN HANDLERS.

OFFICER BAKER AND I CONTACTED AARON ON THE SOUTH SIDE OF THE PROPERTY AND ASKED HIM WHAT HE WAS SAYING TO THE TWO FEMALES HE WAS JUST TALKING TO. AARON STATED HE WAS JUST HITTING ON THEM AND WAS NOT DOING ANYTHING WRONG. I EXPLAINED TO AARON, OFFICERS IN THE AREA HAVE A GOOD RELATIONSHIP WITH THE MANAGEMENT FROM QUICK TRIP AND HAVE EXPRESSED ON MULTIPLE OCCASIONS THEY WOULD LIKE SUBJECTS THAT ARE LOITERING ON THE PROPERTY TRESPASSED IF THEY ARE CONTACTED. I ASKED AARON FOR HIS NAME AND HE STATED HE DID NOT DO ANYTHING WRONG AND HE DID NOT WANT TO PROVIDE ME HIS LAWFUL NAME. I ADVISED AARON I WANTED TO MAKE SURE HE HAD NOT BEEN PREVIOUSLY TRESPASSED FROM THE PROPERTY AND TO VERIFY HE DID NOT HAVE ANY VALID WANTS OR WARRANTS. AARON CONTINUED TO STATE HE DID NOT WANT TO PROVIDE US WITH HIS NAME.

OFFICER BAKER ENTERED THE QUICK TRIP TO CONTACT MANAGEMENT TO VERIFY IF AARON HAD BEEN TRESPASSED PRIOR OR NEEDED TO BE TRESPASSED. WHEN OFFICER BAKER ENTERED THE STORE AARON BEGAN TO WALK BACKWARDS SOUTH BOUND ACROSS THE PARKING LOT AND BEGAN CLENCHING HIS BACK PACK ON HIS LEFT SHOULDER AND BEGAN DISPLAYING SIGNS HE WAS GOING TO RUN. I TOLD AARON TO STOP WALKING AWAY AT THAT TIME OFFICER BAKER WALKED BACK OUT OF THE QUICK TRIP AND I ADVISED AARON I WAS GOING TO BE DETAINING HIM.

I REMOVED THE BLUE BACK PACK FROM AARONS LEFT SHOULDER AND GRABBED HIS LEFT WRIST AND ADVISED HIM TO PLACE HIS HANDS BEHIND HIS BACK. AARON BEGAN TO TENSE HIS BODY AND BEGAN RESISTING OFFICER BAKER AND I. OFFICER BAKER AND I TOLD AARON SEVERAL TIMES TO STOP RESISTING AND TO PLACE HIS HANDS BEHIND HIS BACK. OFFICER BAKER AND I TOOK AARON TO THE GROUND AND CONTINUED TO TELL HIM TO STOP RESISTING AND TO PUT HIS HANDS BEHIND HIS BACK.

AARON CONTINUED TO RESIST AND OFFICER BAKER ARC TESTED HIS TASER AND TOLD AARON IF HE DID NOT STOP RESISTING HE WAS GOING TO GET TASED. I CONTINUED TO TRY AND GET AARONS ARMS BEHIND HIS BACK WHEN AARON BEGAN TO REACH TOWARDS HIS POCKETS AND WAISTBAND WHICH IS A KNOWN PLACE WHERE SUBJECTS HIDE WEAPONS. I THEN TOLD OFFICER BAKER TO TASE AARON AT WHICH POINT OFFICER BAKER PLACED HIS TASER UP AGAINST AARONS LOWER LEFT SIDE AND CONDUCTED A DRY STUN. AARON BEGAN TO COMPLY WITH OUR COMMANDS AND WE WERE ABLE TO PLACE HIM IN CUSTODY.

SEARCH INCIDENT TO ARREST WE LOCATED A KNIFE IN AARONS FRONT LEFT POCKET AND A TRIANGULAR PIECE OF GLASS IN HIS BACK RIGHT POCKET.

OFFICER BAKER AND I ASKED AARON SEVERAL TIMES FOR HIS NAME AND DATE OF BIRTH AND HE PROVIDED THE NAME TAYLOR HARDY AND A DATE OF BIRTH OF [REDACTED] 1980. A RECORDS CHECK WAS CONDUCTED AND A MVD PHOTO DID NOT MATCH TO AARON. AFTER SEVERAL ATTEMPTS AT GETTING AARONS LAWFUL NAME WE LOCATED A GREEN DEBIT CARD WITH THE NAME AARON D JACKSON.

I CONDUCTED A RECORDS CHECK ON THE NAME AARON D JACKSON AND WAS ABLE TO POSITIVELY ID AARON BY HIS MVD PHOTO.

OFFICER BAKER CONTACTED THE MANAGEMENT INSIDE QUICK TRIP AND ADVISED AARON WAS SEEN ON VIDEO LOITERING ON THE PROPERTY AND WAS NOT A PAYING CUSTOMER OF THE BUSINESS. SEE HIS SUPPLEMENT FOR HIS INVOLVEMENT.

WHILE IN CUSTODY AARON REQUESTED PHOENIX FIRE RESPOND TO OUR LOCATION AND TREAT HIM FOR HIS HEAD INJURY FIRE ENGINE 23 B SHIFT CAPTAIN COMPAS ARRIVED ON SCENE AND CLEANED A SMALL ABBRASION ABOVE AARONS RIGHT EYE AND CHECKED HIS VITALS AND STATED HE WAS FINE.

AARON WAS TRANSPORTED TO SOUTH MOUNTAIN PRECINCT WHERE A SINGLE FINGER DIGITAL SCAN WAS CONDUCTED AND AARON WAS POSITIVELY IDENTIFIED AS AARON DWAN JACKSON DOB [REDACTED]/1981.

AARON WAS BOOKED INTO 4TH AVE JAIL.

Narrative Information

ON FEBRUARY 15, 2020 AT APPROXIMATELY 1627 HOURS AP1 AARON D JACKSON WHO WAS LATER IDENTIFIED BY HIS MVD PHOTO COMMITTED TRESPASSING, RESISTING ARREST, AND FAILURE TO PROVIDE ID. AARON WAS OBSERVED ON THE SOUTH SIDE OF THE QUICK TRIP GAS STATION CONTACTING TWO UNKNOWN FEMALES THAT HAD JUST EXITED THE QUICK TRIP AND WERE ATTEMPTING TO ENTER THEIR VEHICLE TO LEAVE THE PROPERTY WHEN THEY WERE CONTACTED BY AARON. OFFICER BAKER 10212 AND I OBSERVED AARON ON THE DRIVERS SIDE OF THE VEHICLE TALKING TO THE TWO FEMALES. THROUGH MY TRAINING AND EXPERIENCE AND PREVIOUS INCIDENTS WITH THE QUICK TRIP EMPLOYEES THEY HAVE HAD ON GOING ISSUES WITH SEVERAL TRESPASSERS AND PAN HANDLERS.

ON FEBRUARY 15, 2020 AT APPROXIMATELY 1630 HOURS WHILE RIDING AS A TWO MAN FULLY MARKED PATROL UNIT WITH OFFICER BAKER IN THE AREA OF S 32ND ST AND E WOOD ST WE OBSERVED A UNKNOWN BLACK MALE LATER IDENTIFIED AS AARON JACKSON, ON THE SOUTH SIDE OF THE QUICK TRIP PROPERTY LOCATED AT 4075 S 32ND ST CONTACTING TWO UNKNOWN FEMALES THAT HAD A DISTRESSED LOOK ON THEIR FACE, WHILE BEING CONTACTED BY THE UNKNOWN SUBJECT WHILE THEY WERE ATTEMPTING TO SAY GOOD BYE TO EACH OTHER AT THE VEHICLES DRIVER SIDE DOOR. AS OFFICER BAKER AND I PULLED INTO THE PROPERTY THE UNKNOWN MALE THEN ENDED HIS CONTACT WITH THE FEMALES AND THEY WERE ABLE TO ENTER THEIR VEHICLES AND LEAVE THE PROPERTY. OFFICER BAKER AND I CONTACTED AARON ON THE SOUTH SIDE OF THE PROPERTY AND ASKED HIM WHAT HE WAS SAYING TO THE TWO FEMALES HE WAS JUST TALKING TO. AARON STATED HE WAS JUST HITTING ON THEM AND WAS NOT DOING ANYTHING WRONG. I EXPLAINED TO AARON, OFFICERS IN THE AREA HAVE A GOOD RELATIONSHIP WITH THE MANAGEMENT FROM QUICK TRIP AND HAVE EXPRESSED ON MULTIPLE OCCASIONS THEY WOULD LIKE SUBJECTS THAT ARE LOITERING ON THE PROPERTY TRESPASSED IF THEY ARE CONTACTED. I ASKED AARON FOR HIS NAME AND HE STATED HE DID NOT DO ANYTHING WRONG AND HE DID NOT WANT TO PROVIDE ME HIS LAWFUL NAME. I ADVISED AARON I WANTED TO MAKE SURE HE HAD NOT BEEN PREVIOUSLY TRESPASSED FROM THE PROPERTY AND TO VERIFY HE DID NOT HAVE ANY VALID WANTS OR WARRANTS. AARON CONTINUED TO STATE HE DID NOT WANT TO PROVIDE US WITH HIS NAME.

OFFICER BAKER ENTERED THE QUICK TRIP TO CONTACT MANAGEMENT TO VERIFY IF AARON HAD BEEN TRESPASSED PRIOR OR NEEDED TO BE TRESPASSED. WHEN OFFICER BAKER ENTERED THE STORE AARON BEGAN TO WALK BACKWARDS SOUTH BOUND ACROSS THE PARKING LOT AND BEGAN CLENCHING HIS BACK PACK ON HIS LEFT SHOULDER AND BEGAN DISPLAYING SIGNS HE WAS GOING TO RUN. I TOLD AARON TO STOP WALKING AWAY AT THAT TIME OFFICER BAKER WALKED BACK OUT OF THE QUICK TRIP AND I ADVISED AARON I WAS GOING TO BE DETAINING HIM.

I REMOVED THE BLUE BACK PACK FROM AARONS LEFT SHOULDER AND GRABBED HIS LEFT WRIST AND ADVISED HIM TO PLACE HIS HANDS BEHIND HIS BACK. AARON BEGAN TO TENSE HIS BODY AND BEGAN PULLING HIS ARMS AWAY FROM OFFICER BAKER AND I. OFFICER BAKER AND I TOLD AARON SEVERAL TIMES TO STOP RESISTING AND TO PLACE HIS HANDS BEHIND HIS BACK. OFFICER BAKER AND I TOOK AARON TO THE GROUND AND CONTINUED TO TELL HIM TO STOP RESISTING AND TO PUT HIS HANDS BEHIND HIS BACK AARON CONTINUED TO PULL HIS ARMS AWAY FROM OFFICERS AND BEGAN TRYING TO REACH TOWARD HIS FRONT POCKETS.

AARON CONTINUED TO RESIST AND OFFICER BAKER ARC TESTED HIS TASER AND TOLD AARON IF HE DID NOT STOP RESISTING HE WAS GOING TO GET TASED. I CONTINUED TO TRY AND GET AARONS ARMS BEHIND HIS BACK AND I WAS ABLE TO SECURE AARONS RIGHT ARM IN THE SMALL OF HIS BACK AND WAS TRYING TO ASSIST OFFICER BAKER WITH HIS LEFT HAND WHEN AARON BEGAN TO REACH HIS LEFT HAND TOWARDS HIS LEFT FRONT POCKET AND WAISTBAND WHICH IS KNOWN TO ME FROM PREVIOUS INCIDENTS WHERE SUBJECTS HIDE WEAPONS. I THEN TOLD OFFICER BAKER TO TASE AARON AT WHICH POINT OFFICER BAKER PLACED HIS TASER AGAINST AARONS LEFT SIDE AND CONDUCTED A DRIVE STUN. AARON BEGAN TO COMPLY WITH OUR COMMANDS AND WE WERE ABLE TO PLACE HIM IN CUSTODY.

SEARCH INCIDENT TO ARREST WE LOCATED A KNIFE IN AARONS FRONT LEFT POCKET AND A TRIANGULAR PIECE OF GLASS IN HIS BACK RIGHT POCKET.

OFFICER BAKER AND I ASKED AARON SEVERAL TIMES FOR HIS NAME AND DATE OF BIRTH AND HE PROVIDED THE NAME TAYLOR HARDY AND A DATE OF BIRTH OF [REDACTED], 1980. A RECORDS CHECK WAS CONDUCTED AND A MVD PHOTO DID NOT MATCH TO AARON. AFTER SEVERAL ATTEMPTS AT GETTING AARONS LAWFUL NAME WE LOCATED A GREEN DEBIT CARD WITH THE NAME AARON D JACKSON.

I CONDUCTED A RECORDS CHECK ON THE NAME AARON D JACKSON AND WAS ABLE TO POSITIVELY ID AARON BY HIS MVD PHOTO.

OFFICER BAKER CONTACTED THE MANAGEMENT INSIDE QUICK TRIP AND ADVISED AARON WAS SEEN ON VIDEO LOITERING ON THE PROPERTY AND WAS NOT A PAYING CUSTOMER OF THE BUSINESS. SEE HIS SUPPLEMENT FOR HIS INVOLVEMENT.

AARON WAS TRANSPORTED TO SOUTH MOUNTAIN PRECINCT WHERE A SINGLE FINGER DIGITAL SCAN WAS CONDUCTED AND AARON WAS POSITIVELY IDENTIFIED AS AARON DWAN JACKSON DOB [REDACTED] 1981.

AARON WAS BOOKED INTO 4TH AVE JAIL.
