ON 020118 AT APPROXIMATELY 1511 HOURS, ARRESTED PERSON DEVON PEDROZA, COMMITTED ASSAULT, DOMESTIC VIOLENCE, BY SHOVING HIS SISTER, REYNA PEDROZA, WHO IS ALSO NINE MONTHS PREGNANT AND CRIMINAL DAMAGE, DOMESTIC VIOLENCE, BY BREAKING A PICTURE, WHILE INSIDE THEIR HOME, LOCATED AT MINUTES LATER, DEVON WAS CONTACTED BY POLICE, ON THE STREET IN FRONT OF THE HOME AND COMMITTED AGGRAVATED ASSAULT ON POLICE OFFICERS, BY SHOVING, OFFICER BELL, SERIAL NUMBER 10028 IN THE CHEST, THEN PUNCHING OFFICER BELL IN THE LEFT JAW. DEVON THEN ATTEMPTED TO PUNCH OFFICER PERU, SERIAL NUMBER 7629, IN THE FACE AND DEVON WAS SUBSEQUENTLY TASED BY OFFICER CANILAO, SERIAL NUMBER 7439. BEFORE DEVON WAS TASED AND WHILE POLICE ATTEMPTED TO PLACE DEVON INTO CUSTODY, DEVON RESISTED BY PULLING HIS ARMS AWAY FROM OFFICER'S GRASPS AND PUNCHING OFFICERS. DEVON WAS TAKEN INTO CUSTODY AT APPROXIMATELY 1535 HOURS, HE ADMITTED TO INGESTING METH.

ON 020118 AT 1529 HOURS, ARRESTED PERSON DEVON PEDROZA, COMMITTED AGGRAVATED ASSAULT ON POLICE OFFICERS, BY SHOVING VICTIM, OFFICER BELL, SERIAL NUMBER 10028, IN THE CHEST WITH BOTH OF HIS HANDS. AFTER OFFICER BELL DEFLECTED DEVON'S ASSAULT AND PLACED HIM ON THE GROUND, ON HIS BACK, DEVON PROCEEDED TO PUNCH OFFICER BELL IN THE LEFT JAW WITH A CLOSED RIGHT FIST. AT THIS POINT, DEVON COMMITTED ANOTHER AGGRAVATED ASSAULT, BY ATTEMPTING TO PUNCH, VICTIM OFFICER PERU, SERIAL NUMBER 7629, IN THE FACE, WHILE STILL ON HIS BACK. HE ARRIVED ON SCENE, IN FRONT OF THE LISTED ADDRESS, WITH OFFICERS CANILAO AND PERU. OFFICER BELL OBSERVED DEVON ON THE NORTH SIDE OF THE STREET. DEVON WAS WEARING NO SHIRT, TAN CARGO SHORTS

AND BASKET BALL SHOES. DEVON IMMEDIATELY STARTED TO YELL AT THE VICTIM, WHO WAS GETTING INTO A WHITE SEDAN, PARKED ON THE NORTH-SIDE OF THE STREET.

DEVON THEN TURNED AROUND AND STARTED WALKING WESTBOUND TOWARDS OFFICERS, IN THE MIDDLE OF THE STREET, JUST A HOUSE AWAY FROM THE LISTED ADDRESS. AS DEVON WALKED TOWARDS OFFICERS, HE PUMPED HIS CHEST AND CLENCHED BOTH HIS FISTS. DEVON YELLED EXPLETIVES AS HE APPROACHED OFFICERS. DEVON IMMEDIATELY WALKED TOWARDS OFFICER BELL AND PASSED HIM. DEVON THEN WALKED BACKWARDS FACING EASTBOUND.

DEVON THEN RUSHED OFFICER BELL, SHOVING HIM IN THE CHEST WITH BOTH HANDS. DEVON PROCEEDED TO SHOVE OFFICER BELL AND OFFICER BELL DEFLECTED DEVON'S ASSAULT AND GRABBED DEVON'S LEFT ARM. OFFICER PERU GRABBED DEVON'S RIGHT ARM AND BOTH OFFICERS, PLACED DEVON ON HIS BACK, ON THE GROUND. DURING THIS TIME, DEVON WAS ABLE TO FREE HIS RIGHT ARM AND PUNCHED OFFICER BELL IN THE LEFT JAW, WITH A CLOSED FIST. DEVON IMMEDIATELY PUMPED HIS CHEST AND CLENCHED HIS FISTS, AS HE WALKED TOWARDS OFFICERS, WHO WERE ON THE SOUTHSIDE OF THE STREET FACING EAST.

DEVON MET OFFICERS, IN THE MIDDLE OF THE STREET AND OFFICER CANILAO DREW HIS TASER. CHEST, AT APPROXIMATELY SIX INCHES AWAY AND USED THE "CROSS CONNECT" TECHNIQUE, WHICH WAS EFFECTIVE. THIS TASER TECHNIQUE ENABLED OFFICERS PERU AND BELL, TO TURN DEVON ONTO HIS STOMACH. DEVON WAS ALSO FOUND TO HAVE A MCSO WARRANT FOR PROBATION VIOLATION. DEVON WAS END OF REPORT.
