\*\*\*\*\*THIS SUPPLEMENT IS BEING GENERATED BECAUSE OF MY INVOLVEMENT IN THIS INCIDENT\*\*\*\*\*

ON 2/1/2018 AT APPROXIMATELY 1517 HOURS, I RESPONDED TO A CALL FOR SERVICE FOR DOMESTIC VIOLENCE AT [REDACTED], LOCATED IN THE CITY OF PHOENIX.

UPON MY ARRIVAL, AFTER AN ALTERCATION WITH THE SUSPECT ON THE CALL, I WAS ABLE TO INTERVIEW THE SISTER OF THE SUSPECT REYNA PEDROZA. REYNA EXPLAINED TO ME THAT SHE CALLED POLICE TODAY, BECAUSE HER BROTHER DEVON WAS "BREAKING EVERYTHING INSIDE THE HOUSE." WHILE INSIDE REYNA SAID DEVON BROKE A MIRROR TYPE OBJECT. REYNA WAS THEN OUTSIDE THE HOUSE IN THE DRIVEWAY, AND THIS IS WHEN DEVON CAME TO THE DRIVEWAY AND "PUSHED" REYNA. REYNA SAID THE PUSHING INCLUDED DEVON MAKING CONTACT WITH REYNA WITH BOTH OF HIS HANDS, WHICH RESULTED IN REYNA MOVING BACKWARDS.
