JAIL AFTER HE WAS SEARCHED BY THE JAIL DETAIL SINCE DEVON WAS COMBATIVE WHEN HE WAS UNDER ARREST IN FRONT OF HIS RESIDENCE LOCATED AT COUNT OF POSSESSION OF MARIJUANA 13-3405A1 A CLASS 6 FELONY. I ALSO REQUEST LAB ANALYSIS FOR THE CLEAR BAGGY WITH A GREEN LEAFY SUBSTANCE BELIEVED TO BE MARIJUANA WHICH WAS SEARCH INCIDENT TO ARREST.
