Narrative Information

THIS SUPPLEMENTAL REPORT IS BEING GENERATED TO ADD INFORMATION INADVERTENTLY FROM THE ORIGINAL REPORT.

AFTER OFFICERS PERU AND BELL, EACH GRABBED ONE OF DEVON'S ARMS, THEY ATTEMPTED TO PLACE HIM ONTO THE GROUND, ON HIS BACK. DEVON ATTEMPTED TO KICK ME WITH BOTH HIS FEET, WHICH PROMPTED ME TO PLACED ALL MY WEIGHT UPON THEM.

AT THIS POINT, I OBSERVED OFFICER PERU KNEELING ON DEVON'S RIGHT FOREARM AND OFFICER BELL, ON DEVON'S LEFT. DEVON CONTINUED TO DISPLAY ACTIVE AGGRESSION AGAINST OFFICERS, BY TRYING TO PULL HIS ARMS FROM UNDERNEATH THE OFFICERS, TO TRY AND HIT THEM. AT THIS POINT, HE HAD ALREADY PUNCHED OFFICER BELL IN THE JAW. I THEN GAVE DEVON COMMANDS TO, "STOP...RELAX. IF YOU DON'T I WILL HAVE TO TASE YOU. IF YOU DON'T COMPLY, I WILL TASE YOU." DEVON THEN YELLED, "GO AHEAD!" DEVON CONTINUED TO PULL HIS ARMS AWAY. ON 020118 AT APPROXIMATELY 1520 HOURS, I DEPLOYED MY TASER WITH SERIAL NUMBER [REDACTED] WITH CARTRIDGES C6203N6Y0 AND C6203N73K.

I FIRST DEPLOYED MY FIRST CARTRIDGE AT DEVON'S STOMACH, WHICH HAD NO EFFECT. A COUPLE OF SECONDS LATER, I DEPLOYED MY SECOND CARTRIDGE AT DEVON'S CHEST AND ATTEMPTED A "CROSS-CONNECT", WHICH MOMENTARILY INCAPACITATED HIM. THIS GAVE OFFICER BELL AND OFFICER PERU TIME TO GET OFF DEVON'S ARMS. DEVON CONTINUED TO RESIST WHILE OFFICERS WERE TRYING TO TURN HIM ON HIS STOMACH TO ENABLE OFFICERS TO PLACE DEVON INTO HAND-CUFFS.

AT THIS POINT, DEVON CONTINUED TO TRY AND KICK REARWARD, AT ME. WHILE DEVON WAS TURNED ONTO HIS SIDE TO SIT-UP, DEVON AGAIN, TRIED TO KICK ME IN THE LEG. THIS PROMPTED ME TO PUSH MY CROSS-CONNECT BUTTON ON MY TASER.

WHILE OFFICER PERU WENT TO OBTAIN A SPIT MASK AND OFFICER BELL CONTACTED THE VICTIM, I HAD MY KNEE AGAINST DEVON'S BACK, WITH THE TASER PROBES STILL CONNECTED. DEVON ADMITTED TO ME THAT HE HAD JUST TAKEN "METH". I GAVE HIM A COMMAND TO, "STOP". WHICH HE REFUSED AND PUSHED AGAINST MY KNEE. I THEN PUSHED MY CROSS-CONNECT BUTTON AGAIN, MAKING HIM SIT BACK DOWN.

AT THIS POINT, I PUSHED MY CROSS CONNECT BUTTON AND INADVERTENTLY TASED MYSELF AND DEVON, AS I WAS SWITCHING HANDS. AFTER A COUPLE MINUTES, DEVON TRIED TO SPIT AT ME, BY LOOKING UP AND BACK TOWARDS ME. OFFICER PERU THEN PLACED DEVON INTO A SPIT MASK. DEVON MADE ANOTHER ATTEMPT TO STAND UP BY PUSHING AGAINST MY LEG, AND I PUSH MY CROSS-CONNECT BUTTON.

FIRE PERSONNEL ARRIVED ON SCENE A FEW MINUTES LATER TO CHECK DEVON, WHICH HE ALSO DISPLAYED AGGRESSION TOWARDS AND YELLED EXPLETIVES AT THEM. OFFICER PERU AND I, EVENTUALLY GOT DEVON INTO THE BACK SEAT OF OUR PATROL TAHOE AND TRANSPORTED HIM DIRECTLY TO THE MADISON STREET JAIL. END OF REPORT.
