ON DECEMBER 03, 2022, AT APPROXIMATELY 0936 HOURS, PHOENIX POLICE OFFICERS WERE DISPATCHED TO 2836 NORTH 27TH AVENUE IN REFERENCE TO A PRIORITY CALL OF A SUBJECT THREATENING WITH A KNIFE. WHILE IN ROUTE, OFFICERS RECEIVED INFORMATION THAT A WHITE MALE SUBJECT, WHO WAS ARMED WITH A KNIFE, HAD THREATENED A VICTIM WHILE AT THE INTERSECTION OF 27TH AVENUE AND THOMAS ROAD. THAT VICTIM DESIRED PROSECUTION FOR THE AGGRAVATED ASSAULT.

Statement of Probable Cause

THE VICTIM LATER TOLD DETECTIVES HE WAS STOPPED AT THE STOPLIGHT AT 27TH AVENUE AND THOMAS ROAD. HE HEARD A BANG ON THE HIS VAN AND STEPPED OUTSIDE TO INVESTIGATE. THE VICTIM SAW A WHITE MALE SUBJECT HOLDING A FIXED BLADE KNIFE. THE MALE SUBJECT POINTED THE KNIFE AT THE VICTIM THREATENING HIM. THE VICTIM PULLED HIS OWN FIREARM AND POINTED IT AT THE MALE SUBJECT IN HIS DEFENSE.

THE VICTIM DROVE AWAY TO THE NEARBY QT AND CALLED 911. THE MALE SUBJECT FOLLOWED HIM TO THE PARKING LOT STILL HOLDING THE KNIFE AND BEGAN THROWING LARGE ROCKS AT THE VAN. THE VICTIM MOVED WESTBOUND ON THOMAS ROAD AND THE MALE SUBJECT CONTINUED FOLLOWING HIM THROWING ROCKS AT THE VAN WITH THE KNIFE IN HAND.

OFFICERS LOCATED THE SUSPECT STANDING IN THE PARKING LOT OF 2825 WEST THOMAS ROAD, WHILE STILL HOLDING A KNIFE IN HIS RIGHT HAND. AS OFFICERS BEGAN GIVING VERBAL COMMANDS FOR THE SUSPECT TO DROP THE KNIFE, HE OBSERVED THE ARRIVING OFFICERS AND RAN AWAY FROM THEM WEST THEN SOUTH ON 29TH AVENUE. THE OFFICERS FOLLOWED HIM ON FOOT UNTIL THE SUSPECT, WHO WAS STILL ARMED WITH THE KNIFE. RAN TOWARDS A VEHICLE THAT WAS STOPPED IN THE ROADWAY JUST SOUTH OF THE INTERSECTION.

ONE OF THE OFFICERS DISCHARGED HIS DUTY WEAPON, STRIKING THE SUSPECT ON HIS LOWER EXTREMITIES. HE WAS TAKEN INTO CUSTODY AND TRANSPORTED TO ST JOSEPHS HOSPITAL, WHERE HE WAS EXPECTED TO SURVIVE.

AFTER BEING RELEASED FROM THE HOSPITAL, THE SUBJECT JOHN TORP WAS TRANSPORTED TO POLICE HEADQUARTERS FOR AN INTERVIEW AND BOOKING. JOHN INVOKED HIS MIRANDA RIGHTS AND WAS BOOKED INTO JAIL.

ON DECEMBER 3, 2022, AT APPROXIMATELY 1030 HOURS, I WAS CONTACTED BY DETECTIVE SERGEANT MURPHY #9213 AND DIRECTED TO RESPOND TO 27TH AVENUE AND THOMAS ROAD REFERENCE AN OFFICER INVOLVED SHOOTING INVESTIGATION. UPON ARRIVAL AT 1126 HOURS, I NOTED THE AREA WAS CORDONED OFF WITH YELLOW CRIME SCENE TAPE AND UNIFORMED OFFICERS WERE PROVIDING SECURITY AND PREVENTING UNAUTHORIZED PEDESTRIAN AND VEHICULAR TRAFFIC FROM ENTERING THE SCENE.

AT APPROXIMATELY 1221 HOURS, I ATTENDED A BRIEFING CONDUCTED BY SERGEANT MURPHY AND LEARNED THE CIRCUMSTANCES OF THIS INCIDENT.

ON DECEMBER 3, 2022, AT 0936 HOURS, THE PHOENIX POLICE DEPARTMENT COMMUNICATIONS BUREAU RECEIVED AN EMERGENCY CALL THAT A TRANSIENT PULLED A KNIFE ON THE COMPLAINANT IN THE AREA OF 27TH AVENUE AND THOMAS ROAD.

PATROL OFFICERS RICHARDS #10242 AND DAUGHTRY #10450 RESPONDED TO THE CALL AS A TWO-MAN UNIT. WHEN THEY ARRIVED ON SCENE, THEY OBSERVED THE DESCRIBED MALE TRANSIENT STANDING NEAR THE BUS STOP ON THE SOUTH SIDE OF THE ROAD EAST OF 29TH AVENUE.

OFFICER RICHARDS OBSERVED THE MALE SUBJECT HOLDING A KNIFE IN HIS HAND. THE MALE SUBJECT RAN AWAY FROM THE OFFICERS WESTBOUND THROUGH THE PARKING LOT. OFFICER DAUGHTRY DEPLOYED THE 40MM LESS LETHAL LAUNCHER AT THE SUBJECT WITH NO VISIBLE REACTIONS. OFFICER RICHARDS CHASED THE MALE SUBJECT ON FOOT THROUGH THE PARKING LOT AND THEN SOUTH ONTO 29TH AVENUE. ROAD. HE HEARD A "BANG" ON THE BACK SIDE OF THE VEHICLE AND GOT OUT TO INVESTIGATE. JAMES OBSERVED A WHITE MALE TRANSIENT WHO CONFRONTED HIM WITH AN 8-10 INCH BLADE KNIFE. JAMES PULLED OUT HIS OWN FIREARM IN SELF-DEFENSE AND THEN DROVE AWAY FROM THE SUBJECT.

JAMES DROVE TO THE NEARBY QT TO CALL 911 AND REPORT THE INCIDENT. THE MALE SUBJECT WITH THE KNIFE FOLLOWED HIM TO THE QT AND THREW ROCKS AT JAMES AND HIS VEHICLE. THE BODY WORN CAMERAS FROM OFFICERS RICHARDS AND DAUGHTRY WERE WATCHED PRIOR TO THEIR INTERVIEWS. BOTH CAMERAS CLEARLY SHOWED JOHN TORP HOLDING A KNIFE IN HIS HAND. JOHN FLED FROM THE TWO OFFICERS ON FOOT AS THE TWO OFFICERS GAVE HIM MULTIPLE VERBAL COMMANDS TO STOP AND TO DROP THE KNIFE.

OFFICER DAUGHTRY FIRED THE 40MM LESS LETHAL LAUNCHER AT JOHN TORP THREE TIMES DURING THE INCIDENT. TWICE ON THOMAS ROAD AND ONCE ON 29TH AVENUE. OFFICER RICHARDS FIRED HIS 9MM HANDGUN AT JOHN TWICE ON 29TH AVENUE, SOUTH OF THOMAS ROAD. AFTER THE FIRST SHOT WAS FIRED, JOHN DROPPED TO THE GROUND AND THEN DROPPED THE KNIFE IN HIS HAND.

JOHN COULD BE HEARD YELLING TO THE OFFICERS THAT HE WAS A PHOENIX POLICE OFFICER MULTIPLE TIMES AND ASKED THE OFFICERS TO CHECK HIS BADGE IN HIS POCKET. BOTH OFFICERS HANDCUFFED JOHN AND THEN CUT HIS CLOTHING FROM HIM TO RENDER FIRST AID.

JAMES GOWAN WAS INTERVIEWED BY DETECTIVE LEGERE #9002. JAMES SAID HE WAS STOPPED TRAFFIC ON THOMAS ROAD ON THE EAST SIDE OF 27TH AVENUE IN THE WESTBOUND LANES AND HEARD A "BANG" ON THE BACK OF HIS VAN. HE EXITED THE VEHICLE TO INVESTIGATE AND OBSERVED A WHITE MALE TRANSIENT WITH A BEARD STANDING AT THE BACK OF THE VAN. THE MALE HELD A KNIFE IN HIS HAND AND EXTENDED HIS ARM TOWARD JAMES POINTING THE BLADE OF THE KNIFE AT JAMES.

IN FEAR OF HIS SAFETY, JAMES PULLED HIS PERSONAL HANDGUN FROM A HOLSTER ON HIS BELT AND POINTED IT AT THE MALE WITH THE KNIFE WHO RAN AWAY FROM THE JAMES AND THE VAN. JAMES GOT BACK INTO THE VAN AND PULLED INTO THE QT PARKING LOT ON THE SOUTHWEST CORNER OF THE INTERSECTION TO CALL 911 AND REPORT THE INCIDENT.

AS JAMES WAS ON THE PHONE WITH 911, THE SAME MALE SUBJECT WITH THE KNIFE APPROACHED THE VAN AND THREW MULTIPLE ROCKS AT JAMES AND THE VAN. JAMES PULLED AWAY FROM THE SUBJECT AND FOLLOWED HIM AS HE RAN WESTBOUND THROUGH THE PARKING LOT AND CONTINUED WESTBOUND ON THE SOUTH SIDE OF THOMAS ROAD.

THE MALE CONTINUED TO PICK UP ROCKS AND THROW THEM AT JAMES AND THE VAN. JAMES OBSERVED THE TWO -MAN PATROL CAR ARRIVE ON SCENE AND OBSERVED THE TWO OFFICERS TRY TO CONTACT THE MALE SUBJECT

WHO STILL HELD THE KNIFE IN HIS HAND. THE MALE RAN FROM THE OFFICERS WEST AND THEN SOUTH ONTO 29TH AVENUE. THE TWO OFFICERS CHASED THE MALE ON FOOT.

JAMES OBSERVED THE MALE WITH THE KNIFE RUN TOWARD A WHITE SUV THAT WAS DRIVING NORTHBOUND ON 29TH AVENUE. JAMES BELIEVED THE MALE WITH THE KNIFE WAS GOING TO ATTEMPT TO CARJACK THE DRIVER OF THE SUV. JAMES OBSERVED ONE OF THE POLICE OFFICERS FIRE AT THE MALE WITH THE KNIFE BEFORE HE REACHED THE SUV. THE MALE WITH THE KNIFE FELL TO THE GROUND AND WAS THEN ARRESTED BY THE OFFICERS.

JAMES DESIRED PROSECUTION AND WILL TESTIFY IF NEEDED. SEE HIS SEPARATE INTERVIEW SUPPLEMENT AND AUDIO RECORDING OF THE INTERVIEW FOR FURTHER DETAILS.

** WALK-THROUGH INTERVIEW WITH PATROL OFFICER RICHARDS #10242 **

WALK-THROUGH INTERVIEWS WERE CONDUCTED WITH PATROL OFFICERS RICHARDS AND DAUGHTRY ON SCENE. FOR SPECIFIC DETAILS REGARDING THE INTERVIEWS SEE THEIR SEPARATE INTERVIEW SUPPLEMENTS AND AUDIO RECORDINGS OF THE INTERVIEWS.

OFFICER RICHARDS WAS THE DRIVER OF THE TWO-MAN UNIT WITH OFFICER DAUGHTRY. HE HEARD THE DISPATCHER ADVISE THE MALE SUBJECT POINTED A KNIFE AT THE 911 CALLER AND WAS CHASING A SECURITY GUARD WITH THE KNIFE. HE OBSERVED THE DESCRIBED MALE SUBJECT HOLDING A KNIFE IN HIS HAND STANDING NEAR THE BUS STOP ON THOMAS ROAD EAST OF 29TH AVENUE.

OFFICER RICHARDS STOPPED THEIR MARKED TAHOE IN THE ROAD AND EXITED THE VEHICLE TO CONTACT THE SUBJECT. HE YELLED AT THE MALE GIVING HIM VERBAL COMMANDS TO STOP AND DROP THE KNIFE. THE MALE WITH THE KNIFE LOOKED AT HIM AND TURNED TO RUN AWAY WESTBOUND. OFFICER RICHARDS CHASED AFTER THE MALE ON FOOT WESTBOUND THROUGH THE PARKING LOT AND SOUTH ONTO 29TH AVENUE.

OFFICER RICHARDS OBSERVED MULTIPLE CIVILIANS STANDING OUTSIDE OF BUSINESSES IN AND AROUND THE LOCATION WHERE THE MALE WITH THE KNIFE WAS AND IN THE DIRECTION HE RAN. THAT INCLUDED THE INITIAL 911 CALLER WHO WAS IN THE PARKING LOT ON THE SOUTHWEST CORNER OF 29TH AVENUE AND THOMAS ROAD.

AS THE MALE RAN AWAY, HE REFUSED TO DROP THE KNIFE AND OFFICER RICHARDS COULD SEE IT STILL IN HIS HAND AS HE CHASED HIM. AS THE MALE RAN SOUTH ON 29TH AVENUE, OFFICER RICHARDS REFLECTED ON HIS OPTIONS TO STOP THE SUBJECT. HE KNEW THE SUBJECT HAD ALREADY THREATENED SOMEONE WITH A KNIFE, HE STILL HELD THE KNIFE AND REFUSED TO DROP IT, THERE WERE MULTIPLE CIVILIANS IN THE AREA OF THE FOOT CHASE, HIS PARTNER HAD ALREADY USED THE 40MM LESS LETHAL LAUNCHER WITH NO AFFECT, HE WAS TOO FAR AWAY FROM THE SUBJECT TO USE HIS TASER, HE FEARED TRYING TO TACKLE THE MAN WHILE HE STILL HELD THE KNIFE IN HIS HAND.

OFFICER RICHARDS THEN OBSERVED A WHITE SUV NORTHBOUND ON 29TH AVENUE, THE MALE WITH THE KNIFE WAS RUNNING TOWARD THE SUV AND HE FEARED IF HE DID NOT STOP HIM, HE MAY TRY TO CARJACK THE DRIVER. OFFICER RICHARDS DECIDED TO FIRE AT THE MALE WITH THE KNIFE AND FIRED TWICE. THE MALE IMMEDIATELY FELL TO THE GROUND. THE OFFICERS GAVE THE MALE VERBAL COMMANDS TO DROP THE KNIFE AND THE MALE FINALLY COMPLIED AND TOSSED THE KNIFE AWAY. THE TWO OFFICERS APPROACHED THE MALE AND HANDCUFFED HIM.

OFFICER RICHARDS STATED HE FIRED AT JOHN TORP IN DEFENSE OF A THIRD PARTY. HE FEARED JOHN WOULD CONTINUE TO HARM OTHERS IF HE WAS NOT STOPPED AND THAT FEAR WAS IMMINENT AS HE OBSERVED JOHN RUN TOWARD THE SUV WITH THE KNIFE IN HAND.

OFFICER DAUGHTRY WAS THE PASSENGER IN THE TWO-MAN UNIT. HE HEARD THE DISPATCHER ADVISE THE 911 CALLER WAS THREATENED BY A SUBJECT WITH A KNIFE AND THE MALE WITH THE KNIFE WAS RUNNING ALONG THOMAS ROAD CHASING OTHERS WITH THE KNIFE IN HIS HAND. OFFICER DAUGHTRY RETRIEVED THE 40MM LESS

LETHAL LAUNCHER AND PREPARED TO USE IT IF NECESSARY.

WHEN OFFICER RICHARDS STOPPED THE TAHOE IN THE ROAD, OFFICER DAUGHTRY EXITED THE TAHOE AND FIRED ONE BATON ROUND AT THE MALE SUBJECT AS HE STOOD ON THE SOUTH SIDE OF THE ROAD HOLDING THE KNIFE IN HIS HAND. HE WAS NOT SURE IF HE STRUCK THE MALE WITH THE BATON.

THE MALE SUBJECT TURNED AND RAN WESTBOUND THROUGH THE PARKING LOT. OFFICER RICHARDS CHASED THE MALE ON FOOT. OFFICER DAUGHTRY FOLLOWED AND FIRED A SECOND BATON FROM THE 40MM LAUNCHER AS HE RAN WESTBOUND BEHIND THE TWO. HE DID NOT OBSERVE IF THE SECOND BATON STRUCK THE MALE WITH THE KNIFE.

THE MALE WITH THE KNIFE TURNED SOUTHBOUND ON 29TH AVENUE AND THE TWO OFFICERS CONTINUED BEHIND HIM. SOUTH OF THOMAS ROAD, OFFICER DAUGHTRY FIRED HIS THIRD BATON AT THE MALE SUBJECT AND BELIEVED HE MISSED. SHORTLY AFTER, OFFICER RICHARDS FIRED AT THE MALE AND THE SUBJECT FELL TO THE GROUND. THE TWO OFFICERS HANDCUFFED THE MALE AND OFFICER DAUGHTRY USED HIS IFAK TO CUT OFF THE MALE'S CLOTHING AND BEGAN TO PROVIDE FIRST AIDE.

JOHN TORP WAS SHOT TWICE, ONCE THROUGH THE HIPS AND ONCE IN THE HAMSTRING. HE WAS TAKEN TO SURGERY TO REPAIR HIS COLON AND THEN MOVED TO THE HOSPITAL ICU. ONE BULLET WAS RETRIEVED DURING THE SURGERY. POLICE OFFICERS GUARDED JOHN AT THE HOSPITAL UNTIL HE WAS RELEASED ON DECEMBER 7, 2022.

JOHN WAS TRANSPORTED TO THE VIOLENT CRIMES BUREAU AT 620 WEST WASHINGTON STREET. HE INVOKED HIS MIRANDA RIGHTS DURING HIS INTERVIEW AND WAS NOT QUESTIONED. JOHN WAS PROCESSED FOR BOOKING AND A SEARCH WARRANT EXECUTED TO SEIZE HIS DNA AND PHOTOGRAPHS OF HIS INJURIES.

JOHN WAS BOOKED INTO THE MARICOPA COUNTY JAIL FOR ONE COUNT OF AGGRAVATED ASSAULT, A CLASS 3 FELONY, AS DEFINED IN ARS 13-1204, AND DISORDERLY CONDUCT, A CLASS 6 FELONY, AS DEFINED IN ARS 13-2904A6.

THIS CASE STATUS IS CLOSED.
