AT 1800 HOURS, WE WERE BRIEFED BY SERGEANT IN TRAINING GAUDET #8885 OF THE CIRCUMSTANCES OF EVENTS UP TO THAT POINT. AFTER THE BRIEFING, I WAS ASSIGNED AS THE CASE AGENT AND TO INTERVIEW OFFICERS TREVINO #10250, WILSON #10351, DEIDA #9242 AND SERGEANT BACKUS #9505, WHO WERE CURRENTLY AT THE SCENE.

BRIEFING:

DURING THE BRIEFING, I LEARNED VICTIM LUIS FERNANDO AVENA FALCON CALLED 9-1-1 TO REPORT A SUSPECT IDENTIFIED AS "JOSE", WHO STABBED HIM THE WEEK PRIOR, WAS AT THE RESIDENCE OF [REDACTED]. RESPONDING OFFICERS WILSON AND TREVINO CONTACTED LUIS EAST OF THE INCIDENT LOCATION. LUIS EXPLAINED THE PRIOR INCIDENT AND DIRECTED OFFICERS TO THE LAST KNOWN LOCATION OF THE SUSPECT. THE RESPONDING OFFICERS ESTABLISHED A PERIMETER OF THE RESIDENCE AND CONTACTED THE OCCUPANTS WHO HAD BEGUN TO EXIT THE RESIDENCE.

NEXT, OFFICERS OBSERVE A MALE, LATER IDENTIFIED AS JAMES GARCIA, WITHIN THE PASSENGER COMPARTMENT OF A LEXUS SEDAN. THE LEXUS WAS PARKED IN THE DRIVEWAY OF THE RESIDENCE, WITH THE ENGINE IN THE ON POSITION AND FACED THE ROADWAY. THE OFFICERS ATTEMPTED TO OPEN THE OTHER DOORS OF THE VEHICLE, HOWEVER, WERE UNSUCCESSFUL DUE TO THE DOOR LOCKS BEING ENGAGED.

OFFICER WILSON OBSERVED A BLACK HANDGUN IN BETWEEN THE DRIVER'S SEAT AND THE CENTER CONSOLE. OFFICER WILSON IDENTIFIED THE WHITE SIGHTS OF THE HANDGUN WHICH HE RECOGNIZED AS A GLOCK. OFFICER WILSON REMOVED HIS HANDGUN FROM THE HOLSTER, POINTED THE FIREARM AT THE SUSPECT, AND TOLD THE SUSPECT TO MOVE HIS HAND OFF OF THE WEAPON.

AS OFFICER TREVINO TRANSITIONED FROM THE FRONT TO THE REAR OF THE VEHICLE JAMES RAISED HIS HANDGUN. OFFICER WILSON YELLED LOUDLY TO JAMES INSTRUCTING HIM TO DROP THE GUN OR HE WOULD SHOOT. OFFICER WILSON CONTINUED TO GIVE JAMES COMMANDS, WHICH WERE IGNORED.

NEXT, OFFICER DIEDA BROKE THE VEHICLE'S PASSENGER SIDE WINDOW. OFFICER WILSON, WHO REMAINED FOCUSED ON JAMES AND THE HANDGUN, OBSERVED JAMES RAISE THE GUN. IMMEDIATELY, OFFICER WILSON DISCHARGED SEVEN (7) ROUNDS FROM HIS HANDGUN INTO THE WINDOW.

OFFICER WILSON STATED HE WAS CONCERNED FOR THE SAFETY OF NOT ONLY HIMSELF BUT FOR THE SAFETY OF THE OFFICERS AROUND THE VEHICLE. OFFICER DIEDA WAS EXPOSED AND LIKELY NOT HOLDING HIS FIREARM. JAMES WAS IN A POSITION AND CAPABLE OF SHOOTING AND KILLING OFFICER DEIDA. ADDITIONALLY, OFFICER WILSON WAS UNABLE TO MOVE FROM HIS POSITION DUE TO A WALL TO THE WEST, A LARGE PIECE OF WORK OUT EQUIPMENT TO THE SOUTH AND A POSITION TO THE NORTH WOULD HAVE PLACED OFFICER WILSON IN THE TRAJECTORY OF THE SUSPECT.

BODY WORN CAMERA AVAILABLE

OFFICER TREVINO EXPLAINED HE AND OFFICER WILSON #10351 WERE RIDING AS A TWO MAN UNIT WHEN THEY RESPONDED TO AN EMERGENCY TRAFFIC CALL OF A SUBJECT WITH A KNIFE.

OFFICER TREVINO CONTACTED THE VICTIM LUIS FERNANDO AVINA FALCON NEAR [REDACTED]. LUIS EXPLAINED WHILE AT [REDACTED] LUIS WAS THREATENED BY A SUSPECT HOLDING A KNIFE. THE SUSPECT WAS LATER IDENTIFIED AS EDUARDO GONZALEZ. EDUARDO HAD COMMITTED AGGRAVATED ASSAULTED WHEN HE STABBED LUIS WITH A KNIFE A WEEK PRIOR IN THE ALLEY WAY. LUIS REPORTED TO OFFICERS ADDITIONAL OCCUPANTS IN THE RESIDENCE HAD GUNS.
