AVENUE AND DUNLAP. AFTERWARDS, JOHNSON AND THE SAME 2-MAN UNIT CONDUCTED A SUBJECT STOP AT THE QT, LOCATED AT 2009 WEST GLENDALE AVENUE. AFTER FINISHING UP AT THE QT, JOHNSON AND THE 2-MAN UNIT PARTED WAYS.

MOMENTS LATER, THE 2-MAN UNIT CLEARED OVER THE RADIO THAT A SUBJECT WAS ACTIVELY THROWING ROCKS AT THEIR MARKED PATROL VEHICLE IN THE AREA OF 19TH AVENUE AND TUCKEY LANE. OFFICER JOHNSON TRAVELED SOUTH ON 19TH AVENUE THROUGH THE INTERSECTION OF TUCKEY LANE AND DID NOT SEE ANYONE IN THE AREA. JOHNSON MET UP WITH THE 2-MAN UNIT IN THE AREA OF 19TH AVENUE AND MARYLAND STREET. ACCORDING TO JOHNSON, OFFICER GIBSON #11108 SAID HE SAW A BLACK MALE SUBJECT THROW ROCK/S AT THEIR PATROL VEHICLE AS THEY PASSED THROUGH THE INTERSECTION, WHICH DAMAGED THEIR SPOTLIGHT. JOHNSON DESCRIBED THE VEHICULAR TRAFFIC CONDITIONS AS MODERATE.

OFFICER JOHNSON SAID AS THE 2-MAN UNIT MADE A U-TURN AND BEGAN TO TRAVEL NORTHBOUND ON 19TH AVENUE, A LESS LETHAL 40MM FOAM PROJECTILE OPTION WAS REQUESTED OVER THE RADIO. JOHNSON SAID HE ACTIVATED HIS OVERHEAD LIGHTS/SIREN AND BECAME THE LEAD VEHICLE AS THEY APPROACHED TUCKEY LANE. AS JOHNSON ARRIVED AT THE TARGET INTERSECTION, AND WHILE STILL IN THE NORTHBOUND LANES, HE SAW A BLACK MALE SUBJECT ON THE SOUTHWEST CORNER ACTIVELY THROWING BASEBALL SIZED ROCKS ACROSS ALL LANES OF TRAFFIC AT HIS PATROL VEHICLE. JOHNSON STATED THE SUBJECT WAS THROWING THE ROCKS WITH HIS RIGHT HAND AND IN THE SAME WAY A PITCHER WOULD THROW A BASEBALL.

OFFICER JOHNSON PULLED INTO THE SOUTHBOUND LANES OF 19TH AVENUE AND EXITED HIS PATROL VEHICLE AND DREW HIS WEAPON. JOHNSON BEGAN TO GIVE VERBAL COMMANDS FOR THE SUBJECT TO "PUT THE ROCKS DOWN", AT WHICH TIME THE SUBJECT THREW A BASEBALL SIZED ROCK DIRECTLY AT HIM. JOHNSON STATED HE HAD TO DUCK IN ORDER TO AVOID BEING STRUCK IN THE HEAD, AS HE FELT THE ROCK COULD HAVE KNOCKED HIM OUT OR POSSIBLY KILLED HIM. MOMENTS LATER, JOHNSON FELT A ROCK HIT HIS LEFT SHIN JUST ABOVE HIS BOOT, AT WHICH TIME HE FIRED HIS DUTY FIREARM.

OFFICER JOHNSON SAID THE SUBJECT FELL TO THE GROUND, WITH HIS HEAD FACING IN A SOUTHWESTERLY DIRECTION. JOHNSON AND THE OTHER OFFICERS ON SCENE CREATED AN ARREST TEAM THAT INCLUDED LETHAL AND LESS LETHAL OPTIONS. THEY APPROACHED THE SUBJECT, ASSURED HE WAS NOT ARMED, THEN CLEARED OVER THE RADIO FOR THE FIRE DEPARTMENT AND BEGAN LIFE SAVING MEASURES.

OFFICER JOHNSON RECALLED FIRING HIS DUTY WEAPON 3 TIMES, FROM A DISTANCE OF APPROXIMATELY 7-10 YARDS.

PHOENIX POLICE OFFICER JOHNSON STARTED THE INTERVIEW BY DESCRIBING HIS UNIFORM:

1. BLACK BOOTS
2. BLUE PANTS
3. OUTER CARRIER THAT INCLUDED A YELLOW AND BLACK TASER, A MOTOROLA RADIO WITH MICROPHONE, BODY WORN CAMERA MOUNT (BODY WORN CAMERA ACTIVATED AT TIME OF INCIDENT), METAL BREAST BADGE AND NAMETAG
4. SHORT-SLEEVED UNIFORM SHIRT WITH PHOENIX POLICE PATCHES ON BOTH ARMS
5. DUTY BELT THAT INCLUDED PEPPER SPRAY, CAR KEYS, CITY ISSUED 9MM GLOCK FIREARM WITH TACTICAL FLASHLIGHT ATTACHED, HANDCUFF CASE, FLASHLIGHT, AND A DOUBLE MAGAZINE POUCH.

OFFICER OLACHEA STATED PRIOR TO THE OFFICER INVOLVED SHOOTING, HE AND HIS PARTNER, OFFICER GIBSON #11108, WERE RIDING AS A 2-MAN UNIT TO AN UNRELATED DOMESTIC VIOLENCE INCIDENT ON WEST CAMELBACK ROAD. GIBSON WAS DRIVING THE POLICE TAHOE AND OLACHEA WAS RIDING IN THE PASSENGER SEAT CHECKING THE MOBILE DATA COMPUTER (MDC). WHILE IN ROUTE TO THE DOMESTIC VIOLENCE CALL, THEY WERE TRAVELING SOUTHBOUND ON 19TH AVENUE IN THE #1 (INSIDE) LANE WHEN THEY PASSED THROUGH THE INTERSECTION OF WEST TUCKEY LANE. AS THEY WERE CROSSING THE INTERSECTION, OLACHEA HEARD A LOUD BANG AND NOTICED THE PASSENGERS SIDE SPOTLIGHT WAS COMPLETELY SHATTERED. OLACHEA WAS TOLD BY GIBSON THAT A SUBJECT HAD THROWN A ROCK AT THEIR PATROL CAR AS THEY DROVE THROUGH THE INTERSECTION.

OFFICER OLACHEA AND OFFICER GIBSON STOPPED THEIR PATROL VEHICLE APPROXIMATELY 250 FEET SOUTH OF TUCKEY LANE AND WAITED FOR OFFICER JOHNSON TO ARRIVE. OFFICER GIBSON CLEARED OVER THE RADIO THAT THEIR CAR HAD BEEN STRUCK BY A ROCK AND THE SUBJECT, WHO WAS STILL STANDING ON THE SOUTHWEST CORNER OF 19TH AVENUE AND TUCKEY LANE, WAS CONTINUING TO ACTIVELY THROW ROCKS AT PASSING CARS. AFTER OFFICER JOHNSON ARRIVED AT THEIR LOCATION, HE WAS BRIEFED ON WHAT HAD OCCURRED AND PROVIDED WITH A DESCRIPTION OF THE SUBJECT WHO WAS THROWING ROCKS. OLACHEA DESCRIBED THE VEHICULAR TRAFFIC CONDITIONS AS MODERATE.

OFFICER OLACHEA AND OFFICER GIBSON CLEARED OVER THE RADIO FOR A 40MM LESS LETHAL FOAM PROJECTILE OPTION, THEN GOT INTO THEIR POLICE CAR AND BEGAN TO DRIVE NORTH ON 19TH AVENUE TOWARDS TUCKEY LANE. ACCORDING TO OLACHEA, OFFICER JOHNSON PASSED THEM AND TOOK OVER AS THE LEAD VEHICLE. AS THEY TURNED FROM 19TH AVENUE ONTO WEST TUCKEY LANE, OLACHEA COULD SEE A BLACK MALE SUBJECT STANDING ON THE SOUTHWEST CORNER WEARING A YELLOW SHIRT. OLACHEA COULD SEE JOHNSON WAS ALREADY OUTSIDE HIS VEHICLE WITH HIS FIREARM DRAWN. OLACHEA GOT OUT OF HIS MARKED PATROL VEHICLE, DREW HIS WEAPON, THEN NOTICED THE BLACK MALE WAS IN THE MIDST OF A BASEBALL STYLE THROW, WITH HIS AIM DIRECTED TOWARDS OFFICER JOHNSON. FEELING THAT OFFICER JOHNSON COULD HAVE BEEN SERIOUSLY INJURED AND OR KILLED, OFFICER OLACHEA DISCHARGED HIS DUTY FIREARM AFTER RECALLING HOW MUCH DAMAGE THE INITIAL ROCK DID TO THEIR PATROL VEHICLE SPOTLIGHT. IMMEDIATELY AFTER THE SHOOTING, OLACHEA CLEARED OVER THE RADIO TO NOTIFY DISPATCH THAT AN OFFICER INVOLVED SHOOTING HAD OCCURRED.

OFFICER OLACHEA SAID THE SUBJECT FELL TO THE GROUND, AT WHICH TIME OFFICER JOHNSON BEGAN TO GIVE VERBAL COMMANDS TO SHOW HIS HANDS. THE SUBJECT WAS MOVING AROUND ON THE GRAVEL/SIDEWALK AREA FOR APPROXIMATELY 20 SECONDS, THEN BEGAN TO SLOW HIS MOVEMENTS, AT WHICH TIME AN ARREST TEAM WAS CREATED. THEY APPROACHED THE SUBJECT AND BEGAN LIFE SAVING MEASURES, THEN CLEARED OVER THE RADIO FOR THE FIRE DEPARTMENT TO ROLL IN.

OFFICER OLACHEA RECALLED FIRING HIS DUTY WEAPON 1 TIME, FROM A DISTANCE OF APPROXIMATELY 50 FEET.
