### \*\*\*SYNOPIS\*\*\*

ON 08/10/2021 AT APPROXIMATELY 0037 HOURS, GREGORY WILLIAMS COMMITTED BURGLARY WHEN HE UNLAWFULLY ENTERED AN APARTMENT AT WITH THE INTENT TO COMMIT A THEFT. GREGORY WAS LOCATED BY A CANINE INSIDE AN APARTMENT ON THE NORTHWEST BUILDING HIDING INSIDE WHAT APPEARED TO BE A BATHROOM. GREGORY HAD A SUITCASE THAT APPEARED HE WAS GOING TO UTILIZE TO STORE STOLEN PROPERTY. GREGORY STATED HE WAS HOMELESS AND WANTED TO SLEEP IN THE BUILDING. GREGORY IS BEING BOOKED FOR BURGLARY IN THE SECOND DEGREE. VICTIM WILL AID IN PROSECUTION.

#### \*\*\*NARRATIVE\*\*\*

ON 08/10/2021 AT APPROXIMATELY 0039 HOURS, I WAS DISPATCHED TO BURGLARY ALARM. PER CALL NOTES, REPORTING PARTY, WHO WORKS FOR AN ALARM COMPANY, STATED HE HAD SEEN A MALE SUBJECT WALK INSIDE AN BUILDING ON THE NORTHWEST SIDE OF THE COMPLEX. REPORTING PARTY GAVE PERMISSION FOR A K9 SEARCH AND ADVISED HE WOULD AID IN PROSECUTION. THE SUBJECT WHO WAS SEEN THROUGH LIVE FEED CAMERA, WAS DESCRIBED AS WEARING DARK CLOTHING AND CARRYING A

#### SUITCASE.

OFFICER FEUDO 11091 AND I ARRIVED ON SCENE. WE NOTICED IT WAS AN APARTMENT COMPLEX THAT WAS UNDER CONSTRUCTION WITH FOUR TOTAL BUILDINGS. WE WALKED THROUGHOUT THE EXTERIOR OF THE BUILDINGS AND WERE UNABLE TO LOCATE ANYONE. PHOENIX POLICE DEPARTMENT DISPATCH TOLD US PER REPORTING PARTY, THE MALE SUBJECT WAS LAST SEEN WALKING INTO THE BUILDING LOCATED ON THE NORTHWEST AREA OF THE COMPLEX. AT THIS TIME, WE REQUESTED K-9 UNIT TO ASSIST US IN CLEARING THE BUILDING. OFFICER FEUDO AND I HELD PERIMETER AROUND THE BUILDING ON THE NORTHWEST UNTIL K-9 ARRIVED ON SCENE. OFFICER FEUDO AND I MADE APPROXIMATELY 10 LOUD VOICE ANNOUNCEMENTS IDENTIFYING OURSELVES AS THE PHOENIX POLICE DEPARTMENT AND IF ANYONE WAS INSIDE TO MAKE THEMSELVES KNOW. I ALSO MADE SPANISH VOICE ANNOUNCEMENT IDENTIFYING OURSELVES AS PHOENIX POLICE DEPARTMENT. K-9 CONDUCTED THEIR SEARCH WHILE OFFICER FEUDO AND I STAYED ON THE NORTHEAST AREA OF THE BUILDING. FOR FURTHER DETAILS ON THE K-9 SEARCH, REFER TO THEIR SUPPLEMENT.

AFTER THE SEARCH, K9 UNIT INFORMED ME THE CANINE HAD BIT A MALE SUBJECT WHO WAS LATER IDENTIFIED AS GREGORY WILLIAMS (IDENTIFIED THROUGH MVD). GREGORY WAS ESCORTED OUT OF THE APARTMENT COMPLEX TO GET MEDICAL ASSISTANCE. OFFICER FEUDO TOOK POSSESSION OF A SUITCASE THAT BELONGED TO GREGORY WHERE IT APPEARED HE WAS GOING TO UTILIZE THE SUITCASE TO PLACE PROPERTY HE WAS GOING TO STEAL. PHOENIX FIRE DEPARTMENT PROVIDED MEDICAL ASSISTANCE, I TRANSPORTED GREGORY TO THE COUNTY HOSPITAL TO GET MEDICAL ASSISTANCE TO GET CLEARED AND THEN BOOK HIM FOR BURGLARY IN THE SECOND DEGREE.

WE ARRIVED AT THE HOSPITAL AND IN A CELL INSIDE THE EMERGENCY ROOM AT APPROXIMATELY 0300 HOURS, I READ GREGORY HIS MIRANDA RIGHTS VERBATIM OFF MY DEPARTMENT ISSUED CARD. I ASKED HIS TO TELL ME WHAT HAD HAPPENED. THE FOLLOWING IS A SUMMARY OF THE INTERVIEW THAT I HAD WITH GREGORY. GREGORY TOLD ME HE IS CURRENTLY HOMELESS AND HAD JUST BEEN RELEASE FROM A DRUG TREATMENT HOUSE. HE ENTERED THE APARTMENTS BECAUSE THE GATE WAS OPEN AND WAS EASY ACCESS. HE SAID HE NEVER HEARD US GIVING OUT COMMANDS BECAUSE HE WAS SLEEPING. HE DENIED ANY BURGLARY ALLEGATIONS. BUT DUE TO HIM UNLAWFULLY ENTERING THE FENCED COMMERCIAL, HAVING A BACKPACK TO HIDE ALL PROPETY HE WAS READY TO STEAL. IT APPEARED THEY WERE GETTING TO ROB THE SORE. END OF CONTACT.

AFTER GETTING MED RELIESE AT THE HOSPITAL, GREGORY WAS BOOKED INTO ITR WITHOUT AN INICENT.
