Narrative Information

THIS SUPPLEMENT WAS GENERATED TO DOCUMENT THE MOMENTS LEADING UP TO WHEN DAVID MASTRANZO COMMITTED AGGRAVATED ASSAULT ON A POLICE OFFICER BY SPITTING IN MY FACE WHILE OFFICER WILLIAMS 7558 AND I WERE INVESTIGATING A DOMESTIC VIOLENCE CALL FOR SERVICE AT [REDACTED].

ON MARCH 15, 2021 OFFICER WILLIAMS AND I WERE OPERATING AS 825I A TWO MAN UNIT WHEN WE RESPONDED TO EMERGENCY RADIO TRAFFIC TO THE HOME LOCATED AT [REDACTED] NE REFERENCE A DOMESTIC VIOLENCE. INFORMATION ON THE CALL INDICATED A VERBAL FIGHT BROKE OUT BETWEEN ROBERTA AND HER SON DAVID WHO WAS HAVING A [REDACTED] EPISODE. FURTHER INFORMATION REVEALED DAVID HAD A PELLET GUN HANDGUN AND HE WAS THREATENING ROBERTA.

WILLIAMS AND I HAVE BEEN TO THIS HOME ONCE BEFORE IN REFERENCE TO A DOMESTIC VIOLENCE INVOLVING DAVID AND ROBERTA. DAVID SHOWED SIGNS OF MENTAL ILLNESS AND A DISLIKE FOR THE POLICE AND HE WAS ULTIMATELY TRANSPORTED TO THE PHOENIX CHILDREN'S HOSPITAL.

ON THIS INCIDENT OFFICER WILLIAMS AND I WERE MET IN THE DRIVEWAY BY ROBERTA AND DAVID. DAVID WAS STANDING BEHIND ROBERTA WITH HIS HANDS IN THE AIR AS IF HER WERE TOLD TO PUT HIS HANDS UP. WILLIAMS CONTACTED ROBERTA AND I CONTACTED DAVID. DAVID IMMEDIATELY BECAME AGITATED WITH WILLIAMS AND I AS I WERE FRISKING HIM FOR WEAPONS.

WHILE FRISKING DAVID HE TOLD ME "GET YOUR FUCKING HANDS OFF OF ME" AND HE CALLED ME "NIGGER" OVER TEN TIMES LOUD ENOUGH THAT HIS OFFENSIVE WORDS COULD HAVE BEEN HEARD BY THE NEIGHBORS. DURING THE FRISK DAVID INDICATED THAT HE HAD A PELLET GUN ON HIM IN A POUCH ON THE FRONT OF HIS PERSON. ONCE I REMOVED THE POUCH WHICH CONTAINED THE PELLET GUN DAVID BECAME MORE AGITATED WITH ME AND ATTEMPTED TO WALK AWAY FROM ME AND CALLED ME A "NIGGER" AND OTHER OFFENSIVE WORDS LOUDLY.

IN AN ATTEMPT TO GET DAVID TO CALM DOWN I GRABBED HIM BY THE ARM AND WALKED HIM OVER TO A COUCH WHICH WAS ON THE FRONT PORCH. I THEN PUSHED DAVID DOWN ON THE COUCH AND INSTRUCTED HIM TO SIT ON THE COUCH AND TO NOT MOVE. WHILE DAVID WAS SITTING I BEGAN TO REMOVE ITEMS FROM HIM SUCH AS HIS RED BACKPACK AND OTHER PERSONAL ITEMS WITHIN HIS SWEATSHIRT FRONT POCKET. WHILE SPEAKING WITH DAVID AND ATTEMPTING TO GAIN ANY SORT OF VERBAL CONTROL OVER HIM OR GETTING HIM TO CALM DOWN I OBSERVED WHAT APPEARED TO BE A GLASS PIPE IN HIS LEFT HAND. THE SUSPECTED PIPE IN HIS HAND APPEARED TO BE SIMILAR TO A METH PIPE AS THEY BOTH A CLEAR GLASS AND CONTAIN A SLENDER TUBE. I GRABBED DAVID'S HAND AND ORDERED HIM TO OPEN HIS HAND, WILLIAMS HAD TO ASSIST ME WITH GETTING DAVID TO OPEN HIS HAND. DAVID EVENTUALLY LET GO OF THE OBJECT IN HIS HAND AND I WAS ABLE TO TAKE A CLOSER LOOK AND CONFIRM THE PIPE WAS IN FACT PIPE WHICH IS COMMONLY USED TO SMOKE METHAMPHETAMINES. ALSO WITH THIS PIPE THERE WAS A TOOTER PLACED INSIDE OF THE TUBE OF THE GLASS PIPE. A TOOTER IS A STRAW LIKE DEVICE AND IN MOST CASES IS AN ACTUAL STRAW ONLY THEY ARE CUT TO A SHORTER LENGTH ABOUT THREE TO FOUR INCHES. A TOOTER IS USED DURING THE CONSUMPTION OF FENTANYL WHICH IS COMMONLY IN PILL FORM. THE MOST COMMON PILL FORM WHICH FENTANYL IS USED IS AN M30, A SMALL

ROUND BLUE OR LIGHT GREEN PILL WITH THE MARKING M30. THIS TOOTER WAS A SHORTENED STRAW AND CONTAINED A BLACK RESIDUE AND A PARTIALLY MELTED END WHICH IS COMMON ON MOST STRAW TOOTERS AS THE PLASTIC MELTS WHEN AN M30 IS SMOKED.

ONCE THE PIPE WAS RETRIEVED FROM DAVID, WILLIAMS ADVISED ME THE WE WERE GOING TO PLACE DAVID INTO HAND CUFFS. DAVID SHOWED AN IMMEDIATE DISLIKE FOR WILLIAMS PLAN AND TRIED TO RESIST WILLIAMS AND I PUTTING CUFFS ON HIM. AFTER A SMALL STRUGGLE, CUFFS WERE PLACED ON DAVID AND I SAT HIM BACK DOWN ON THE COUCH. IT WAS AT THIS TIME THAT DAVID COMMITTED AGGRAVATE ASSAULT AGAINST A POLICE OFFICER BY SPITTING BODILY FLUIDS ONTO MY FACE AS I WAS STANDING IN FRONT OF HIM. I WAS POSITIONED APPROXIMATELY TWO FEET AWAY FROM DAVID AS I WAS STANDING SLIGHTLY BLADED TO HIM AND LOOKING ON THE TABLE TO DAVID'S LEFT WHEN I HEARD DAVID MAKE A SPITTING SOUND AND THEN FELT SALIVA HIT THE LEFT SIDE OF MY FACE. IN RESPONSE TO DAVID SPITTING AND TO PREVENT DAVID FROM SPITTING ON ME AGAIN OR ANYONE ELSE, I GRABBED HIM BY THE FACE AND TURNED HIS HEAD AWAY FROM ME. WILLIAMS ASSISTED ME WITH TAKING DAVID TO OUR PATROL VEHICLE WHERE HE WAS PLACED INTO THE BACK SEAT.

I REQUEST THAT THE STATE CHARGE DAVID WITH AGGRAVATED ASSAULT FOR SPITTING ON ME ESPECIALLY DUE THE POTENTIAL RISK THAT DAVID EXPOSED ME TO IN REGARD TO COVID 19.

WILLIAMS CONDUCTED THE REST OF THE INVESTIGATION THUS ANY FURTHER INFO CAN BE FOUND ON HIS ORIGINAL REPORT.
